The topics for discussion at the meeting are described below.

For each of the items mentioned a subgroup has been set down in order to prepare the work. The coordinator is mentioned under each item. If you have not already flagged your interest to the Bureau you can contact the coordinators directly.

## 1. Service products prices and production

The main topic of the meeting in Örebro is PPI for services products. Three sessions will be devoted to this issue:

- Based on the discussions in Madrid principal papers for pricing Telecommunication, Accounting, Legal and Real Estate shall be presented as a model for pricing a sector in detail.
- Four new service activities (Computer services, Insurance, Banking, Advertising, Courier services or Market research) will be addressed in a two-years process for developing a model paper for presenting an international practices in these areas.
- Quality adjustment techniques and fitness for use criteria for evaluation of indices and their use by national income accounts.

In addition to being important in its own right, the work will be very important for the development of the CPC. As the purpose of the price indices will be to deflate the estimates of output, it is important to know whether the CPC, as presently developed, is suitable for the collection of both revenues and prices or needs to be modified in the light of the experience of compiling price indices.

## 2. Information Society statistics

There is an increasing and pressing demand by governments and other users to obtain indicators on the Information Society in its broadest definition. To meet these demands the OECD Working Party on Indicators for the Information Society and the Voorburg Group has decided to cooperate closely in this area. The topics that will be discussed on the meeting concern

- ICT usage
- ICT sector (consequences of the coming NACE 2002 revision, proposal for indicators)
- ICT Services (identification of ICT services in terms of CPC)
- Contents sector (proposal for a delineation)
