Draft classifications for service statistics
Revised proposals from Sweden concerning:

- COMPUTER AND RELATED ACTIVITIES (Ref ISIC)
- SOFTWARE AND OTHER COMPUTER SERVICES (Ref CPC)

1. Comments

The Swedish proposal regarding computer related activities (Memo July 1987) was distributed without consideration being taken to the Japanese comments, as these were not available at the time. What follows is a reconsideration of our original proposal after having read the Japanese comments and also some rethinking of our own.

First we would like to suggest a more specified class instead of 8502 Software supply. This class could be named "Noncustomized software creation" and should include the creation of non-customized software programs, that is operating systems, utilities and application programs. As a consequence the creation of customized software services should be classified in class 8501.

In our July Memo we suggested that "Data bank activities" should be transferred to division 96 "Recreational, cultural and sporting activities", (according to the UN draft of the revised ISIC), which should be renamed "Information supply, cultural and sporting activities". Our Japanese colleagues disagree to this and want data bank activities to be classified with computer related information service activities. The reason for this is that these activities include as a main element the provision of data which are organized and stored in a certain order or sequence using computers and related OA equipment.

The reason for our own suggestion is that we look upon data bank services as a means to provide information, and that the information content of this activity thus is more important than the technology used.

As far as maintenance and repair of computer systems is concerned we thought that such a class would be appropriate in a world level classification. However, we have learned that the situation in Japan is about the same as in Sweden; there are very few establishments whose speciality or main economic activity is the maintenance and repair of computers. Therefore, we would like to reformulate our July suggestion and join the Japanese proposal that no such class should be established. If it is necessary to do so in view of other countries, it would be appropriate to classify those activities in section 2 "Manufacture of metal products, machinery and equipment" or section 6 "Wholesale and retail trade".

The situation in Japan as in Sweden is such that maintenance and repair is carried out by enterprises producing, reselling and/or leasing those computers.

Japan also suggest that a new class, not considered in our July proposal nor in the UN draft, should be established for other computer activities not mentioned before. New services may then be covered when they come into existence.

Our suggestions are listed below.

2. List of suggested subdivisions

- 626x Wholesale of computers, computer equipment and software products (incl. commission trade)
- a Wholesale of computers, computer equipment and electronic components
 - b Wholesale of software

Remarks: Should electronic products (i.e. computers etc, electronic components and related services; see also CPC 252 and 271 in the part of transportable goods) generally be separated in the classifications according to their primary field of application: (i) Administrative data processing; (ii) Data processing in engineering and manufacturing and other technical processing (e.g. such as in automatic traffic systems)?

8501 Computer and software consultancy
(Information system development services)

Description: This class includes designing, developing and establishing information systems by combining information equipment, software and communication equipment upon request of clients.

Exclusions: Similar services made by computer producing or selling units as an integrated part of the equipment delivery contract.

- a Computer and software consultancy services (incl. computers, cables, networks, software products, consulting and training).

8502 Non-customized software

Description: This class includes the creation of non-customized software programs (operating systems, utilities and application programs).

Exclusions: Similar services made as an integrated part of the reselling of software and hardware (operating systems). Creation of customized software services is classified in class 8501.

- a Non-customized software
- b Non-customized software application services (for instance creation and/or revision of documentation related to the software such as users' manuals).

8503 Data processing services

Description: This class includes the processing or tabulation of all types of data as a separate technical facility service.

This may consist of the complete processing and preparation of reports from data supplied by the customer. It may also be specialized, i.e. key-punching or other input preparations, conversion such as card to tape etc, optical character recognition and others.

The services may be supplied either over-the-counter or via remote access terminals and may employ either the customer's or the producer's program.

- a Batch data processing services
- b Remote data processing facility services
- c Computer facilities management services
- d Backup facilities services

96XX Database service activities (moved to ISIC division 96, see comments above)

Description: This class includes the providing of information from structured data bases through electronic means.

Exclusions: Electronic information services provided interactively where the user may add to or change items in the data bases, such as videotex, teletex and electronic mail are classified elsewhere. Also, credit checking data base services are classified elsewhere (?).

8509 Other computer related information service activities.
