

Services in the Classification of Goods for
Production Statistics

Preliminary remarks

The following discussion will present the services in the Classification of Goods for Production Statistics (GP). Proceeding from the purpose and the structure of this classification, it will be shown for which "industrial" services definitions have been available and data have been collected for a long time already in German statistics. The paper further contains considerations on methodological questions and gives an outline of the guidelines for a further extension of the GP by a service section.

1. Functions of the Classification of Goods for Production Statistics

The essential part of the Classification of Goods for Production Statistics (GP) derives from a commodity classification for the surveys of enterprises in production industries, which was already introduced in 1947. Its basic concept has essentially been retained despite several revisions made in the meantime. During its application over almost 40 years it has proved an important instrument for the observation and analysis of production as well as of the cyclical and economic development.

The introduction to the 1982 edition of the GP, which is now in force, states on the intended use: "The Classification of Goods for Production Statistics is an important part of the system of official classifications for the presentation of commodity flows. It is intended as a general or basic classification for all statistics recording predominantly data on goods produced in the sectors of agriculture, forestry and fishery as well as in production industries."

Besides the basic classification, there are derived versions of the classification of goods for specific statistics. They differ from the basic classification by a less detailed breakdown and/or other aggregations and by the restriction to specific goods or groups of goods, respectively. The GP thus creates the prerequisites for a most uniform allocation possible of goods in all relevant statistics. It provides, among others, the basis for the following surveys:

- quarterly production survey
- quick report on production
- statistics on materials and goods received in production industries
- statistics on the trade in goods with Berlin (West)
- statistics on the trade in goods with the German Democratic Republic and Berlin (East)
- statistics on foreign trade prices
- statistics of producers' and wholesale prices

Used in connection with national accounts, the Classification of Goods for Production Statistics constitutes among others the basis for the description of production units by means of goods in the Classification of Spheres of Production for Input-Output Calculations (SIO).

The numbers (codes) of the classification of goods moreover explain and describe the sectors

of the Industrial Classification of Economic Activities, Edition 1979. The types of goods of the classification may at the same time be used to form designations of establishments or similar specifications within the corresponding branches of economic activity.

2. Volume and structure of the Classification of Goods for Production Statistics

The GP consists of two parts:

Part 1: Classification of Goods for Agriculture, Forestry and Fisheries
Part 2: Classification of Goods for Statistics in Production Industries

It comprises a total of

41 two-digit groups of goods,
268 three-digit categories of goods,
1 104 four-digit classes of goods and
6 293 six-digit types of goods.

There belong to Part 1: Classification of Goods for Agriculture, Forestry and Fisheries

5 two-digit groups of goods,
20 three-digit categories of goods,
72 four-digit classes of goods and
587 six-digit types of goods.

Part 2: Classification of Goods for Statistics in Production Industries comprises

36 two-digit groups of goods,
248 three-digit categories of goods,
1 032 four-digit classes of goods and
5 706 six-digit types of goods.

Because of the criteria of production economy chosen for the analysis of the classification of goods, the two-digit groups of goods are closely connected with the corresponding elements of the Industrial Classification of Economic Activities, Edition 1979 and with the version for statistics in production industries derived from it. These classifications are listing the branches of economic activity according to which the results of the respective statistics are analysed. These branches of economic activity comprise enterprises/holdings with the same or a similar product range. The product ranges of the individual branches of economic activity can be presented exhaustively using the types of goods of the Classification of Goods for Production Statistics.

Most groups of goods distinguish three-digit categories of goods. It seemed neither meaningful nor necessary to provide in all groups for aggregations at this level of analysis. They are only worthwhile if groups of goods comprise several comprehensive kinds of goods which can clearly be distinguished from each other with regard to important characteristics.

Four-digit classes of goods, on the other hand, have been established for all groups of goods. Each of them comprises types of goods which are similar enough to secure sufficiently homogeneous aggregations. The classes should for many purposes constitute an adequate and sufficient level of analysis.

The six-digit types of goods are the actual "reporting numbers" and at the same time the items for which as a rule data are collected in the various statistics.

A numerical key is used for the identification of the individual items of goods.

3. Services in the Classification of Goods

3.1 Outline of the presentation of services

As can be seen from the previous remarks, the GP is, as far as its contents are concerned, a nomenclature of commodities, as have already been its predecessors which were still referred to as commodity classifications. Nevertheless, service items have always constituted a basic element of these nomenclatures without, however, making special reference to the fact that this "commodity principle" has been violated.

The present GP contains the following service categories:

Services on the level of the agricultural producer,

Services of commercial gardening and animal keeping,

Services on the level of the forestry producer,

Services for fisheries,

Contract and commission work

Processing work under contract

Processing work for own account

Assembling,

Repairs,

Scrapping (dismantling).

The services as a rule are listed at the end of each group of goods (two-digit level). There they first constitute a category of goods (three-digit level), which generally is subdivided into the classes of goods (four-digit level) repairs, processing work under contract, assembling and dismantling. The classes of goods finally are often further broken down into several types of goods (six-digit level).

Contract and commission work is a special case. It does not have a six-digit key, but is identified by adding a special key to the six-digit types of goods.

The differentiation of the types of services within the individual groups of goods depends on the respective importance of the services and their reference to the goods. While the types of services assembling and repairs can be connected with most of the commodities, this is not true in the case of processing and dismantling. The services to be allocated to the sectors of agriculture and forestry are also of a special nature and treated separately in the GP. According to the material requirements, the service part of the individual groups of goods is therefore more or less strongly marked. There are also several manufacturing sectors within the production industries that are already providing services directly, as for instance the surface treatment (surface refinement) and hardening. Such services are given special emphasis in the GP. The following list (table) shows a typical extract of services from the GP.¹⁾

3.2 Explanations concerning individual services

3.2.1 Services to be allocated to agriculture, forestry and fisheries

Part 1 of the GP (Classification of Goods for Agriculture, Forestry and Fisheries) contains services especially geared to agriculture, forestry and fisheries. Due to their individual nature, they elude a systemization as it is for instance possible in the case of repairs. They are therefore explained by means of examples and listed only in Part 1 of the GP. This part, in turn, does not contain any "industrial" services.

3.2.2 Contract and commission work

In the case of contract and commission work materials supplied free of charge by another enterprise are treated or processed into a new product.

The special situation in connection with the recording of contract and commission work has already been pointed out above, since contrary to the other services the GP does not provide a separate six-digit key for contract and commission work. The producer must rather allocate the goods produced in contract and commission work to the reporting numbers provided for the individual goods. For identifying contract and commission work, a one-digit key is in this case, however, added to the six-digit items of goods. This procedure on the one hand permits to completely cover the quantity of production of an article and on the other hand enables a realistic presentation and interpretation of the statistical results with regard to the value data.

3.2.3 Processing work under contract

There is processing work under contract if a product furnished free of charge by the customer is finished under a job order. As a general principle this does not yield another product. Finishing includes for instance dying, impregnating, imprinting, varnishing, stamping, etc..

Most of the groups of goods have been provided with separate six-digit items for processing work under contract (processing work

under contract relating to products of this group of goods). Some groups of goods however do not have items for processing work under contract (e.g. the groups of goods 28 = Non-ferrous metals and semi-finishes [incl. precious metals and their semi-finishes], 29 = Foundry products, 33 = Road vehicles [excl. agricultural tractors], 34 = Watercraft). This is on the one hand due to the fact that goods of these groups as a rule are not processed under contract, while on the other hand the processing work under contract is performed by enterprises that have not specialized in the processing of goods of specific groups. In order to permit a presentation, items for metal and non-metal coatings and other surface finishing work as well as for welding, grinding and similar work performed on a contract and commission basis have been included in group 30 = Products of drawing plants, cold rolling mills and steel shaping. A detailed breakdown for processing work has also been included in group 63 = Textiles. It included such work as repairing, fashion designing, pattern drawing, plissé heating, plissé pressing and stitching.

These explanations show that the analysis of processing work under contract has been adapted to the respective circumstances in the branches of economic activity and that one cannot speak of a uniform regulation of this matter.

3.2.4 Processing work for own account

Own-account processing work exclusively covers the processing of goods that have been bought by the processing enterprise and after finishing will be sold again without any additional processing.

The presentation of own-account processing work is limited to the groups of goods 22 = Mineral-oil products, 30 = Products of drawing plants, cold rolling mills and steel shaping, 40 = Chemical products and 58 = Plastics products. If the finishing work represents only one step in the manufacturing of own-account products, it is not to be shown separately.

3.2.5 Assembling

The term assembling is used in the GP in different ways. On the

one hand, an assembly is the mounting of parts to produce a machine, a vehicle or an appliance, but on the other hand also the building-in and installation of goods on the premises of the user.

In the case of larger machines or mechanical plants, the final assembling is often carried out only on the premises of the user, so that a separation of services for assembling with the producer and the installation on the premises of the user is very difficult or may not be achieved at all. Assembling may also be performed, however, by enterprises specialized in assembling, i.e. firms performing exclusively assembling work (main activity).

The allocation of the assembling services on the basis of the GP varies correspondingly. One has to distinguish two cases:

- assembling of products that have been produced in the reporting enterprise itself. The value of assembling has in this case generally be added to the production value of the respective products. If however this gives rise to difficulties (e.g. with large plants) such kind of work may be shown under the special reporting numbers for assembling. For structural steel engineering products (group 31) and for prefabricated constructions (group 70) there is however the special regulation stating that assembling of own-account products has to be allocated as a general principle to the assembling items.
- assembling of products that have not been produced entirely or largely by the reporting enterprise. This value of assembling must be shown separately under the reporting numbers for "assembling" which have been provided for the individual groups of goods.

3.2.6 Repairs

Repairs require a similar knowledge and similar activities as does the assembling of the product. Repairs are therefore often carried out also by the producing firm itself.

For the purposes of the GP, mere maintenance services, such as the examination of the proper operation of a machine, a vehicle and the

like (e.g. maintenance of planes) without repairs are not part of the repairs since they have been allocated in the Industrial Classification of Economic Activities to the service sector.

3.2.7 Dismantling and scrapping

For dismantling and scrapping services the GP provides reporting items in the groups of goods 31 = Structural steel engineering products and rail vehicles, 32 = Mechanical engineering products, 34 = Watercraft, as well as 35 = Aircraft and spacecraft. In other groups of goods corresponding reporting items are missing (e.g. in group 33 = Road vehicles).

4. Concept of coverage

The explanations concerning the GP do not contain any methodological references to the service items. The user therefore has to analyse the service items himself, to compare them with the commodity items, and, if necessary, to draw upon the explanations for the quarterly production surveys.

On the basis of the example for services shown under point 3.1, the following methodological criteria can be derived:

- The service concept of the GP comes closer to a designation of an activity than of a commodity.
- The GP does not provide for quantity units, but only for the indication of values.
- A production for further processing is not covered.

4.1 Designations of activities

The most important criterion for determining the services resulting from these considerations is that activities rather than goods are used for designating services. This way of determining services manifests itself especially in connection with services on the level of the agricultural producer, and of commercial gardening. These services are defined as follows:

Services on the level of the agricultural producer include:

Taking charge of activities on the level of the agricultural producer which usually are carried out by the agricultural holdings themselves, e.g. ploughing, threshing, milking, drying of grain and tobacco, agricultural pest control, tending of farm animals, seed dressing and cleaning, harvesting and packing of fruit and vegetables, tree trimming.

Services in landscape gardening include for instance:

Establishing, sowing and planting of lawns including for parks, sports grounds, playgrounds, highways and other roads.

Although goods are the object of "agricultural" and "industrial" services which usually leave material traces on the object, as for instance in the case of vacuum metallization, not the latter but the activities are covered.

4.2 Quantity component

In the case of goods, the GP and the quarterly production surveys provide that the production intended for sale shall generally be covered according to its value and for most of the goods additionally with a quantity component. For services, however, there is as a general principle no quantity component provided. This is, however, first of all a question of survey technique and only secondarily a question of classification. It is, however, obvious that the decision to designate services by means of activities considerably limits the selection of output-related quantity components. As regards services, the GP therefore provides for only three exceptions to the exclusive recording of value. These are:

- Repairs of transport containers and rail vehicles. In addition to the value of the repairs, the number of the goods repaired is recorded.
- Contract and commission work. Here, the goods produced have to be reported with their reporting number by quantity and the value of the contract and commission work.
- Textile finishing work. For certain finished textiles, there has to be reported in addition to the value also the quantity of the finished textiles in kilogramme or square metres.

4.3 Internal services of enterprises

The coverage of internal services of enterprises is closely linked with the coverage of quantity components. While the GP contains a number of goods for which not only the production intended for sale, but also the production to be processed in the same establishment must be reported, there are no such items in the case of services. One reason why such items are lacking should be, among others, that unlike for the production of goods the recording of quantities is very difficult in the case of services, because the production intended for further processing is covered in terms of quantity only. A recording of the value of services for further processing on the other hand is not meaningful since such value data would be costs, i.e. input values, which must not be combined with sales proceeds.

5. Problems of definition and coverage in connection with services of the Classification of Goods for Production Statistics

Definition problems for industrial services arise with assembling and processing work under contract. In the case of assembling, there are for instance difficulties if, in addition to the assembling of machines and appliances in the manufacturing firm, assembling and installation work has to be made on the premises of the customer. Costs for such assembling work may have been considered by the producer in the selling price, but the work may also be carried out by a third enterprise charging its assembly work separately. The production statistics do not reveal the different volume of services. Moreover, the assembling service could also be seen as fitting work, i.e. part of the production process itself, carried out by a subcontractor. Another example for problems of coverage is the assembling of complete products from kits. For assembling work of this kind, only the value of assembling is covered, whereas there is no information on the assembled goods.

Another problem arises with the definition of contract and commission work in group of goods 30 = Products of drawing plants, cold rolling mills and of steel shaping. This group of goods comprises establishments having specialized in specific services, such as hardening as well as quenching and tempering. The services of these holdings have their own reporting positions. If the same services are performed by other non-specialized enterprises, they fall under the heading of processing work under contract. Some other re-

porting items of this group may, moreover, have too large a margin for interpretation. When drawing up the GP, attention has been paid to including every product only once. It can, however, not be excluded that the activity "General welding work" also includes the production of goods explicitly mentioned elsewhere.

There do of course exist at the Federal Statistical Office concepts as to how these and other problems can be solved. The problems discussed above may however be neglected, given the loss of information which the compulsory introduction of the Central Product Classification (CPC) by the Statistical Office of the European Communities would entail.

6. Proposals concerning the Central Product Classification

In order to maintain the current state of information of German statistics, it would be necessary to provide for a considerably more detailed breakdown of "Agricultural, mining and industrial services" in the CPC. Section 7 could be used to this end. Its Divisions 74-79 are not yet occupied. These divisions would permit a differentiation extending beyond the breakdown of CPC-Group 898, as may be seen from the following example:

For the field of contract and commission work, the current level of information can, however, be maintained only if the present five-digit items of goods are extended by one digit for an additional key. In this connection it should at the same time be examined whether further services should be coded in such a sixth digit.

7. Further extension of the Classification of Goods for Production Statistics

The GP is presently being revised by the Federal Statistical Office. The main emphasis is in this connection on the updating of the existing positions. Furthermore, an assimilation to the Harmonized System is aimed at. A classification of services is developed together with the revision of the GP. Basis of this classification is the services section of the CPC. More specifically, the following principles will be followed:

- The "industrial" services shown above remain in the already existing GP because of their insufficient consideration in the CPC.
- As from Division 84 "Restaurant and hotel services" onwards, the items of the CPC will be adopted. (Excl. Group 898). Where these are services which could be performed by units of the production industries as well - e.g. services related to computer software - or services attributable to "business services", these items are to be further developed, providing in particular for an additional subdivision according to German requirements.
- Instead of the term services, the most concrete designations possible of the activities shall be used. Only where this does not seem appropriate, because the text would otherwise become too long, there might be a deviation from this principle. In such a case the services will however have to be further specified.
- The CPC code proper will be preceded by the figure 8 for all items retained. The positions extending beyond the CPC draft will as their seventh digit have the key 1 to 9.
- It is intended to extract in a further step from the new section of the classification the services rendered by enterprises or establishments of production industries and to combine them to a "special classification". In future, data shall be collected in the quarterly production survey for this special classification as for the already existing items of the GP.

A draft coordinated at the Federal Statistical Office is to be available by the end of May 1987.
