The French Annual Survey on Service Industries

The attached table presents some results from the French Survey on service industries. The survey is part of the general French system of annual surveys on enterprises (enquêtes annuelles d'entreprises). It is the last to have been launched, in the early 1980s, and it is directly managed by INSEE. Over the years, its scope has been extended, and it concerns presently all market services, except financial services, health, social care, education and research activities. Sixty-seven sectors at the four digit level of the French classification of activities and commodities (NAP: "Nomenclature d'activité et de produits") are now covered, involving some 600,000 firms and 2,500,000 persons in 1989.

The survey is a survey on firms or "entreprises", in the sense of juridically independent profit making entities. Liberal professions, as lawyers or accountants, are included, but non profit organization are not. The service firms surveyed are classified according to their main activities and can have one or more local units.

This survey is conducted by sending, by mail, a detailed questionnaire to all firms with twenty or more salaried employees, and a simpler one to a representative sample of the smaller firms. The sample for the latter is stratified by size categories and activities (the sampling rate varies between 1 down to 1/100), and is renewed by half each year.

Basically, the survey provides detailed information on the current income accounts of the firms, as well as complementary information on their labor force and capital assets.

The larger firms have to report their statement of income and expense for the last accounting period ("fiscal year") with a breakdown of some 30 operations (sales of merchandises, purchased goods and produced services; purchases of goods and raw material; changes in inventories; taxes; wages and social security costs; interest incomes and expenses; profits and losses). All firms are asked to give a detailed breakdown of their total turnover ("Chiffre d'affaires") by commodities (450 different commodities), and also a detailed one of their purchases (about 35 categories including "goods and services purchased for resale" and various intersectoral exchanges).

As to labor, the following items are asked for: the total number of salaried employees at the end of the year, with a distinction between professionals (i.e., managerial, executive and supervisory personnel), other full-time employees, part-time employees and apprentices; total number of non salaried persons with a distinction between owners and associates (or independent workers), full-time family workers and part-time ones. Total number of hours worked by salaried employees during the calendar year is also asked for, along with corresponding wage bill.

Concerning capital assets, larger firms have to report the gross book values of their fixed assets which are registered in their balance sheets at the beginning and end of their fiscal year, and they have to provide a breakdown of the change in gross book value, occurred over the fiscal year, in terms of acquisition, cessions, discounts, revaluations and other adjustments. For all firms, investment expenditures (measured on the basis of acquisitions) are separated into seven categories: land, new and existing buildings and structures; new and second-hand transportation equipment; new and second-hand machinery and other equipment.

About 90,000 questionnaires have been sent out for the survey on 1988 in March 1989. The rate of non reply has been about 20%, nearly half of which corresponding to firms which have ceased their activities in 1988. In terms of number of firms the rate of missing, incomplete or erroneous data is thus about 20%, but is only about 6% in terms of employees or value added. Starting in 1990 for the year 1989, the sample has been extended to 100,000 questionnaires in order to improve the results at intra-regional levels.

The operational definition of the main activity of a firm depends on the detailed breakdown of the sales by the firm itself. A "weight" is attributed to each kind of sale (e.g. the weight is equal to 1 for a "pure" service sale, and equal to 1/9 for a resale activity); in a first round the main 4-digit weighted activity is calculated, then a the intermediate 4-5 digits activity is calculated within the 4-digit activity and eventually a 5-digit activity is computed in the same way within the 4-5 digit activity.

The table provides the main results of the survey according to the new classification of activities of the European community (NACE Rev 1), based itself on the ISIC. Since a lot of firms includes resale of services or goods in their turnover (or sales), a variable called margin is computed. The margin is equal to:

turnover (sales) + changes in inventories - goods and services purchased for resale.
