PROPOSED EXPLANATORY NOTES TO THE CPC

Divisions 94 to 99

- The present document makes wide use (when it does not make direct copy) of two papers :
- a working document by EUROSTAT on proposed explanatory notes to the CPA (document of DG 34/B5 n°B5/NACE/93/2);
- a excerpt of the explanatory notes to the CPF (French version of the CPA) as presently existing in the classification data base SYNAPSE.
- 2. The writer of this paper claims all responsibilities on its content :
- as to the language, when technical terms have to be translated from French to English by a non technician, or, more generally, when a paper in English has to be written by a Frenchman!
- as to the content, which the writer has either endorsed from the two reference documents, or which he may have modified from one of them two or from both.
- 3. The provisional CPC has been published in an official UN publication (Statistical Studies, Series M, n°77; New York 1991). This document, which the author had only in its French version, provides a detailed structure of the CPC, which may differ, in some cases, from the classification which was provisionally approved during the 1989 meeting of the Statistical Commission (ST/ESA/STAT/SERM.M/77) and confirmed by the Commission during its 1991 meeting; some discrepancies will be presented hereafter. The document presents also explanatory notes for the service part of the CPC. Most of these notes have been taken into account in the EUROSTAT document which has been used for preparing the present proposal.
- 4. The first discrepancy between the published UN document and the Statistical Commission document concerns the addition of four classes, with one sub-class each, to the group 940 (sewage and refuse disposal, sanitation and similar services). The four sub-classes (and classes) have the following headings:
- 94040. Purification services of burnt gaz
- 94050. Services of fighting against noises
- 94060. Protection services of nature and landscapes
- 94090. Other services of protection of environment

Obviously, these four sub-classes were added in view of creating classification of services connected to environment. But such a classification, like many others such as the classification of services connected to tourism, is somewhat "transversal" to the CPC, and, in the author's opinion, should not be "forced" into it. It is therefore proposed not to take into account the four classes and sub-classes, and to consider that sub-classes 94040 and 94050 are included in group 912 (services to the community as a whole), while sub-classes 94060 and 94090 are included in sub-class 96332 (nature reserves services including wildlife preservation services).

5. Another discrepancy between the two UN documents concerns audiovisual services. In the explanatory notes of the UN publication, a sub-class 96114 is described, which has the heading "other services connected with production and distribution of motion pictures and video tapes". This heading does not appear neither

in the detailed structure of the CPC in the same document, nor in the Commission document. It is however proposed to add it to the detailed structure in order to make a distinction between services clearly connected to production or to distribution and ancillary services.

- 6. Six other points for discussion are worth mentioning :
- in class 9611 (motion picture and video tape production and distribution services), sub-class 96111 (services in connection with promotion or advertising) has been deleted in the CPA (regroupment with other sub-classes); it has no corresponding explanatory note in the UN publication cited in paragraph 3; contrarily to the CPA, it is proposed to keep this sub-class in the CPC provided that its coverage corresponds to the explanatory note proposed in this paper (keeping this sub-class permits to separate movie making services taken without (96111) and with commercial risks); is the interpretation in line with what should be covered by sub-class 96111?
- sub-class 96133 (combined programme making and broadcasting services) has been deleted in the CPA (regroupment with other sub-classes); it has no corresponding explanatory note in the UN publication cited in paragraph 3; contrarily to the CPA, it is proposed to keep this sub-class as a separate one for purposes of making classification easier since combined services are rather frequent; is this position agreeable?
- there is a need for making a clear separation between discotheques where people can dance on music from a juke box or from similar appliance, and bars where such equipment exists ;
- in the CPA, all services of news agencies have been regrouped in one sole heading; should not this be proposed also for the CPC?
- the classification of fitness, body building, ... centres is not clear: either with "sports facilities operation services" (96413),or with "other services related to sports events" (96419), or with "other beauty treatment services" (97029)?
- sub-class 96411 (sports events promotion services) has no corresponding explanatory note neither in the UN publication nor in the EUROSTAT document; is the explanatory note proposed in the present paper in line with what should be covered by the sub-class?
- 7. From the experience acquired in the French annual surveys on enterprises, there is not much difficulty for applying the CPC as proposed, at least, as to the products which are surveyed, which do not include recreational, cultural and sporting services, except audiovisual services.

This paper has three annexes:

- annex I presents the proposed explanatory notes to CPC, for divisions 94 to 99;
- annex II presents the headings of the CPA, classified within the headings of the CPC;
- annex III presents the classification used for reporting the breakdown of their turnover by audiovisual enterprises as to audiovisual and connected activities, in the French annual survey on enterprises (as a reminder of the standard survey on audiovisual services proposed at the Williamsburg meeting of the Voorburg Group (1992)).

94 SEWAGE AND REFUSE DISPOSAL, SANITATION AND SIMILAR SERVICES 940 Sewage and refuse disposal, sanitation and similar services 9401 Sewage services

94010 Sewage services

This sub-class includes:

- management and maintenance services of sewers (unitary or separative networks)
- services of draining of "used" waters, services of treatment and disposal of muds, rejection of epurated waters
- services of emptying and cleaning of cesspools, septic tanks and chemical toilets

This sub-class excludes :

- construction and repair services of sewage systems (51350) and of purification plants (51390)
- distribution services of epurated waters (18000)

- disposal of refuse services by incineration
- disposal of refuse services by other means such as dumpin on land or in water, burial, or ploughing-under

- disposal services of agricultural or industrial refuse, whether solid or liquid, using a special treatment
- treatment services of toxic, contaminated, and radioactive waste, including cleaning of polluted soils
