PROPOSAL FOR A CLASSIFICATION OF PRODUCTS LINKED WITH TOURISM

ABSTRACT

The object of this study is that of identifying a proposal for the classification of products linked with tourism inspired by the Classification of Products by Activities (CPA) through an analysis of the correspondences between the CPA itself and the Standard International Classification of Tourism Activities (SICTA).

This document is structured in three parts:

- a) an explanation of the methodology adopted and of the operating steps;
- a description of and a comment to the recommended classification of the products linked with tourism;
- c) a detailed table with the individual items of CPA-Tourism.

INTRODUCTION

The object of this study is that of identifying a proposal for the classification of products linked with tourism inspired by the Classification of Products by Activities (CPA) through an analysis of the correspondences between the CPA itself and the Standard International Classification of Tourism Activities (SICTA).

This document is structured in three parts:

- a) an explanation of the methodology adopted and of the operating steps;
- a description of and a comment to the recommended classification of the products linked with tourism;
- c) a detailed table with the individual items of CPA Tourism.

For further details please see the document "Proposals for a linkage between SICTA and CPA" presented at the meeting between Eurostat and the CLAS Group on the "Project on service classifications" on 1 June 1993, and its enclosures.

1. OPERATING METHODOLOGY

Three steps can be identified within the work that has been carried out:

- a) linkage between SICTA and CPA;
- b) verification of the real links between the two classifications;
- analysis of the degree of comparability between the corresponding items,
 together with a proposal for possible improvements.

For the execution of the work, reference has been made to the following documentation:

- descriptions of CPA, version of the classification updated to 21 October 1992;
- descriptions and explanatory notes of SICTA, version of the classification contained in the document: "Draft Standard International Classification of

Tourism Activities", joint EC/EFTA meeting of the Working Group on 'Statistics on Tourism', 13 and 14 February 1992.

1.1 Linkage between SICTA and CPA

The first step consisted in the automatic determination of a first linkage between SICTA and CPA.

As a starting point two different existing links were assumed:

- that between the four classifications that constitute the basic core of the international nomenclature system: the International Standard Industrial Classification of all Economic Activities revision 3 (ISIC Rev.3), the Nomenclature Générale des Activités Economiques dans les Communautés Européennes revision 1 (NACE Rev.1), the Central Product Classification (CPC) and the Classification of Product by Activities (CPA);
- that between SICTA and ISIC Rev.3.

After preparing the appropriate correspondence tables and checking that they are correct, all possible correspondences between SICTA and CPA have been identified, exploiting the transitivity of the links.

All these activities were carried out on the basis of queries and automatic processing of PARADOX data.

1.2 Verification of the real linkages between the two classifications

Although considerable efforts have been made to ensure that the linkages between the mentioned classifications were as coherent as possible, several cases of equivocal and non-univocal correspondences do exist. It follows that the automatic procedures adopted in the previous step have brought to light a

number of correspondences that is higher than those actually existing between the two classifications.

It is necessary at this stage to subject all proposed correspondences to careful verification in order to identify and to confirm only those links that relate to products linked with tourism.

The result of the analysis carried out has led to the confirmation of about 22% of the proposed links, keeping 484 correspondences among the 2,187 that were identified by the automatic procedure.

1.3 Analysis of the degree of comparability and proposal for improvements

The third and conclusive step of the work consisted of a thorough examination of the comparability between the two classifications by comparing the degree of correspondence existing for each level of aggregation.

Clearly, as the level of detail rises, the more the classifications differ one from the other and the correspondences are no longer univocal (of the one-on-one type), but equivocal (of the one-on-many, many-on-one or even many-on-many type).

The analysis also makes some suggestions related to proposals for modifying the classifications to attempt to solve these cases of equivocal correspondence and to make the links between the two classifications as univocal as possible.

An attempt has also been made to define a measure of the incidence of the tourism component linked to products identified in the CPA, assigning a T or a P to each item where such incidence was total or partial.

The criteria of determination of the degree of the incidence of the tourism component are altogether similar to those adopted for SICTA and described in the document "Draft Standard International Classification of Tourism Activities": the tourism component has a total incidence on a product (or a service) when it

is prevalently destined to tourist supply or when its purchase represents a substantial portion of the outlay of tourists.

The results of this step are given in the second part destined to comments on and a description of the proposed tourist product classification.

2. DESCRIPTION OF AND COMMENT ON THE PROPOSED CLASSIFICATION

As mentioned in the previous pages, 484 correspondences between the two classifications have been confirmed during the step of verifying the links between SICTA and CPA.

These 484 correspondences involve 457 CPA items, split as follows according to the level of detail:

As can be seen, Table 1 distinguishes the items related to the division "45 Construction" whose presence is due to the inclusion in SICTA of the construction sector among the activities linked with tourism.

In actual fact the criterion according to which these activities are included in SICTA appear to be highly debatable.

Indeed the "tourism" factor is linked with the sectors of supply and demand of services more than with those of the production of goods. The construction of a

building as a production activity is not linked with tourism, whereas the possible use to which it will be destined (hotel or restaurant, commercial centre or sports arena) will indeed be linked with tourism, that is, to the service supplied.

But if construction is considered as an activity linked with tourism then a large number of production activities will also have to be considered in a similar manner. This will apply to all those activities involved in the production of goods sold to tourists (even though they are already considered in trade) or used in the supply of services to tourists (already considered in the relevant service). In this way everything would be found to be linked with tourism.

It has therefore been preferred in the present study to exclude the sector of construction from the analysis, in which services only are being considered. As a result of this choice the number of correspondences between the two classifications is reduced to 455.

2.1 Analysis of correspondences

Since SICTA has been obtained from ISIC Revision 3, while the CPA derives directly from NACE Revision 1, that, as is well known, is structured so that it can be inserted in full coherence in ISIC Revision 3, it has been possible in general to obtain accurately the correspondences between the items of the two classifications.

Table 2 gives a picture of the items of the two classifications from which construction has been excluded. The correspondences found have again been split with reference to the level of detail of the items in the CPA.

As can be seen, there is a substantial coherence between the two classifications at the more aggregated levels that drops as the detail of the items rises, with CPA being more structured with respect to SICTA.

For example, at the first level, that with 2 digits, there is a perfect univocal correspondence between SICTA and CPA, but as the detail of the items increases, these correspondences become more and more rare and the equivocal links increase.

Since CPA is more structured than SICTA and the two classifications are built up with coherent criteria, these equivocal links are prevalently of the one-on-many type in which several SICTA items correspond to one CPA item.

This fact also emerges clearly from Table 2 where it can be seen that the number of CPA items and the number of correspondences obtained at the different levels of detail is very similar.

In all these cases the proposed classification of products linked with tourism is more detailed than SICTA's that is a classification of activities linked with tourism. This is utterly coherent with the criteria regulating the relationships between the classifications of products and those of activities; indeed, both SICTA and CPA are more detailed than their respective classifications of activities, ISIC Rev.3 and NACE Rev.1.

The matter of equivocal links of the many-to-one type, where several CPA items correspond to one SICTA item, and of the many-to-many type, where several CPA items correspond to several SICTA items, is something else, due to the different criteria of disaggregation adopted in the two classifications. Under these circumstances it would appear appropriate to do something with the proposed classification, expanding the details given in CPA, as will be shown better in paragraph 2.3.

2.2 Problems of correspondence between SICTA and CPA

Not all correspondences between SICTA and CPA are immediately due to a cross-link of the two classifications but there are some cases where the search for such correspondences has determined the rise of a few problems that are still open.

Before presenting the two more complex cases that have been highlighted, it should be noted that frequently such problems of correspondence between the two classifications have arisen due to the non-adoption on the part of SICTA of the residual classes to complete the necessarily incomplete detail of its items.

SICTA sub-class 5510-6

Within the class 5510 "Hotels, camping sites and other", SICTA introduces the detail of the sub-class 5510-6, "Health-oriented accommodation", that, as opposed to the others, does not have a direct correspondence with the CPA categories.

It is possible to consider this case as:

- A. the identification on the part of SICTA of a category transversal to those defined by CPA that is superimposed over the classes included in the groups 55.1 "Hotel services" and 55.2 "Camping sites and other short-stay accommodation services", and is thus redundant;
- B. a lack of detail on the part of the CPA, so that the corresponding item would be 55.23.15 "Other short-stay accommodation services".

CPA sub-category 60.20.41

The SICTA class 6021, "Other scheduled passenger land transport", corresponds to the CPA class 6021, "Other scheduled passenger land transportation services".

Inside this, SICTA has a further breakdown into four categories, but the explanatory notes are not sufficiently clear in defining which of these subclasses correspond to the CPA sub-category 60.20.41, "Passenger transportation by funiculars, teleferics and ski-lifts".

Such sub-category in fact represents a type of service that is undoubtedly linked with tourism.

2.3 Proposals for changing the classification of products linked with tourism.

We give below the proposals for changing the classification of products linked with tourism, with respect to the CPA one from which it is derived. The object of these proposals is to overcome the cases of equivocal correspondences between SICTA and CPA in which several CPA items correspond to one SICTA item and those in which several SICTA items correspond to several CPA items.

The code numbers or the descriptions which it is proposed to modify with respect to the CPA are shown in *italics* in the tables that follow. To maintain the integrity of the CPA all proposed modifications are obtained by adding one digit to the CPA item for which it is appropriate to increase the detail.

CPA sub-category 52.48.22

The SICTA main-class 5239 "Other retail sales in specialized stores", has a direct correspondence with the similar CPA class 52.48.

Moving down to more disaggregated levels, it can be seen that in this case it is SICTA with the sub-classes 5239-1 ("Retail sales, scuba gear, diving equipment"), 5239-2 ("Retail sales, skiing equipment"), 5239-3 ("Retail sales, camping, hiking equipment") and 5239-4 ("Retail sales, hunting and fishing

equipment") that gives greater detail than CPA that merely defines the subcategory 52.48.22 "Retail trade services of sports goods".

As a consequence it is proposed to proceed by increasing the detail of item 52.48.22 as follows:

CPA category 61.10.1

The SICTA main-class 6110 "Sea and coastal water transport" corresponds exactly to the similar CPA class 61.10 "Sea and coastal water transportation services".

If we analyse the greater detail of the two classification there do emerge, however, a few problems in defining the links.

In fact, each of the two classifications highlights some details that are not provided for in the other: such as the SICTA sub-class 6110-1 "Cruise ships" that has no corresponding item in CPA, and the CPA sub-category 61.10.11 "Passenger transportation by ferries" that has no correspondence in SICTA.

The CPA category 61.10.1 could be modified as follows to improve comparability with SICTA's by adding a sub-category:

CPA class 61.20

Something similar to what has been discussed in the previous point can also be said here

The SICTA class 6120 "Inland water transport" again corresponds exactly to the similar CPA class 61.20 "Inland water transportation services" but here again the two classifications have different disaggregations that determine an equivocal correspondence of the many-on-many type.

In fact, with 2 CPA sub-categories (61.20.11 "Passenger transportation by ferries" and 61.10.12 "Other passenger transportation") SICTA has a detail that is more accurate but it has no residual item.

It is therefore recommended that the classification be as follows:

It is also pointed out that, as opposed to sea-going transportation, in the case of inland waterways transportation SICTA does not consider any detail related to rental activities of vessels with a crew (CPA sub-category 61.20.31 "Rental services of non-sea-going vessels with crew").

CPA sub-category 63.30.12

The CPA class 63.30 "Travel agency and tour operator services: tourist assistance services n.e.c." corresponds exactly to the SICTA class 6304 "Travel agents, tour operators and guides".

Here again, if we go into further detail of the two classifications, there is a correspondence of the many-on-many type, that it is proposed to overcome by making the following classification of products linked with tourism:

CPA classes 71.10 and 71.21

Within these two CPA classes there is an equivocal correspondence of the many-on-many type with the SICTA class 7111, determined by the adoption of two different criteria of detail.

In fact, CPA defines separately the hire of self-drive cars and lumps together the hire of motorcycles, caravans and campers; but SICTA considers the hire of motor vehicles and motorcycles in one item and the hire of caravans and campers in another.

The following is therefore the proposal to distinguish between the three types of hire.

CPA sub-category 71.40.14

The CPA class 71.40 "Renting services of personal and household goods n.e.c." corresponds to the SICTA class 7130 "Renting of personal and household goods".

If we go further into the details of the two classifications we see that SICTA's is more structured than that of the CPA's.

The CPA sub-category 71.40.14 "Leasing or rental services concerning pleasure and leisure equipment" could be changed to:

CPA sub-category 75.11.12

The CPA class 75.11 "General (overall) public services" corresponds exactly to the SICTA class 7511 "General public service activities". If we go to a further detail SICTA is more structured than CPA within the category 75.11.12.

Here again it is sufficient to disaggregate the CPA item as follows to make the correspondence between the two classifications more uniform:

CPA sub-category 75.13.14

In a manner altogether similar to the previous case, it can be seen that the CPA class 75.13 "Administrative services for the more efficient operation of business" corresponds to the SICTA class 7513 "Business regulation".

Since the structure proposed by SICTA goes into greater detail with respect to the CPA, it is suggested that the following disaggregation be adopted for the sub-category 75.13.14:

CPA sub-category 80.30.12

The CPA sub-category 80.30.12 is a residual item for which SICTA has a better level of detail.

It is therefore proposed to disaggregate CPA as follows.

CPA group 80.4

The CPA group 80.4 "Adult and other educational services" corresponds to the SICTA group 809 "Adult education". But these two classifications have a different internal structure with SICTA being the more detailed.

To get the same details with CPA some items should be disaggregated as follows:

CPA sub-category 91.33.14

The CPA class 91.33 "Services furnished by other membership organizations n.e.c." corresponds to the SICTA class 9199 "Other membership organization". Both are residual classes but if we go deeper into details, SICTA proposes a higher structure than CPA, distinguishing two items that it is appropriate to reproduce in the latter as well by disaggregating the residual category 91.33.14 "Other services provided by membership organizations n.e.c." as follows.

CPA sub-category 92.61.10

The SICTA class 9241 "Sporting activities" corresponds to two CPA classes, 92.61 "Sports facilities operation services" and 92.62 "Other sporting services". Within the class 92.61, as opposed to SICTA, CPA has a detail limited to just one sub-category, 92.61.10 "Sports facilities operation services". As a consequence it is suggested that the detail of this sub-category be increased by structuring it as follows:

CPA sub-category 92.72.12

The SICTA class 9249 "Other recreational activities" corresponds to two CPA classes, 92.71 "Gambling and betting services" and 92.72 "Other recreational services".

Within this latter class the detail given by the CPA is lower than that offered by SICTA, it is therefore suggested that the classification be extended as follows:

3. CLASSIFICATION TABLES

The enclosure gives the tables of correspondence between CPA-Tourism and SICTA.

Each of the CPA-Tourism items has been marked with a T or with a P according to whether the incidence of the component linked with tourism is total or partial.

The CPA-Tourism items in *italic* do not belong to the CPA itself but were obtained by increasing the detail of CPA for those items where SICTA is structured to a higher degree.
