- 6. In view of the shortness of time available, no systematic analysis of the information is possible. A few general conclusions are offered in what follows.
- 7. The first is that the number of OECD Member countries that compile producer prices for services is limited. Some countries -- Austria, Finland, Spain and Switzerland -- replied that they do not compile producer prices for services; it can be assumed that this is also the case of most non-respondents.
- 8. The number of service categories for which producer prices are compiled is also limited for most countries. Most compiling countries focus on transportation and communications.
- 9. As regards the types of prices observed, there is a predominance of transaction prices, with list prices, model prices and hourly rates playing only a marginal part.
- 10. Quality adjustments are made for many service categories, but some of them are partial or limited.
- 11. The use made of producer price indices are various. Some countries use them mainly for deflation in the National Accounts, whilst others use them for constructing indices and for research purposes.

Prices for Intermediate Services: The ONS Approach.

1. History

- 1.1 The service sector now accounts for around two-thirds of gross domestic product. It is widely recognised that partly for historical reasons less is known about the sector than about manufacturing industry. In order to help remedy this situation, the Office for National Statistics (ONS) has been engaged in a programme to improve the statistical coverage of the sector.
- 1.2 As part o(this programme, the ONS has since 1991 prepared, but not published, price indices for five service industries. These are:
 - road haulage
 - contract cleaning
 - waste disposal
 - bus and coach hire
 - private (non-school) educational services.
- 1.3 Collection has been carried out quarterly on a voluntary basis. The resultant price indices have been used to deflate turnover data, and thus provide a measure of real output for use in the calculation of GDP by output.
- 1.4 Price quotations are collected either for specific service activities (for example, the collection and disposal of a skip filled with a particular kind of waste) or for contracted services (for example, the provision of cleaning services to a specific office block). In the latter case, care must be taken to ensure that price movements are accurately captured at the time of contract change.
- 1.5 Contributors are asked to notify the ONS of any quality changes, and to estimate the impact of such changes on prices. The effects are then discounted..
- 1.6 Confidentiality of information supplied to the ONS is protected under the Statistics of Trade Act, 1947.

2. Developments

- 2.1 Early in 1995, Ministers gave their approval to plans for further improving the coverage of the prices charged for intermediate services (that is, services provided by one business to another). Developments include:
 - progressive expansion to cover the bulk of the services sector; putting the survey onto a statutory basis;
 - eventual monthly collection, where needed for the deflation of turnover data obtained on a monthly basis.
- 2.2 Ultimate outputs of the new developments will be:
 - a summary index of price movements for business services;
 - a set of high-quality deflators covering individual service industries, and which contribute to improved estimates of GDP by output.
- 2.3 Priority will be given to those industries which are relatively important in the construction of GDP by output, and to those industries where the problems of measurement are less severe.
- 2.4 Data collection for the existing industries has recently been placed on a statutory basis. Collection has also recently started for five new industries. These are:
 - accountancy
 - -- consulting engineering
 - courier services
 - security services
 - -- sewerage services.
- 2.5 From January 1996, therefore, prices data will be collected quarterly on ten service industries. In total, there will be around 500 contributors providing prices for around 1,500 service activities.
- 2.6 Research is also in progress on computer services, sea and coastal transport, and the hire of construction equipment.

3. Issues

- 3.1 Measuring prices for 'services raises a number of difficulties. In a some service industries, two features cause particular problems. These are:
 - -- the provision of one-off products (e.g. in consulting engineering);

Parallel developments are taking place within the RPI to improve the coverage of services provided to the consumption sector.

- -- the intangibility of the output provided to customers (e.g. in management consultancy).
- 3.2 Where these features mean that actual prices are not available, the options include measuring changes in 'model prices' or in 'price determinants'.
- Model prices are prices for fictional but typical services. Often they would be based on repricing previous jobs. Disadvantages include concerns over whether productivity growth would be reliably measured, and whether prices would realistically reflect prevailing market conditions. Compliance costs could also be very high. This means that in many cases it may be better to measure price determinants.
 - 3.4 Measuring price determinants involves the separate identification of movements in:
 - fees (or in wages plus mark-up) per period;
 - productivity.
 - Measuring productivity change for services is a major challenge. We are confident that for a number of industries it will be possible to make progress. For instance, in Canada, civil engineers have taken part in a programme with the national statistical office to re-estimate the labour hours required to complete a set, of typical projects. This work has been judged a success.
 - 3.6 One option is to combine the measurement of fees per period with a -smaller-scale and less frequent model-pricing or productivity measurement exercise.
 - 3.7 The ONS intends to adopt a pragmatic approach for the more difficult industries. Data on fee rates will be collected at an early stage, with work on productivity and/or model prices following as developments allow.
