1. Definition of service being collected

- Establishments engaged in providing maintenance and repair service of motor vehicles and motorcycles (JSIC* 891)
 - In principle, excluding establishments which provide maintenance as well as selling motor vehicles (except selling on commission)
 - --> Wholesale or retail industry

*JSIC: Japan Standard Industrial Classification

2. Market conditions and constraints

Scale of maintenance and repair of motor vehicles sector (comparison with the industrial total)

- Number of establishments: 59,323 (0.98%)
 - 99.9% are privately owned establishments
 - 90.9% have less than 10 employees

Output : 6.438 trillion yen (0.4%)

Gross value added: 2.937 trillion yen (0.6%)

GVA / Output : 45.6% (GVA/Output for total: 34.4%)



2. Market conditions and constraints

Maintenance system in Japan


- Inspections and checkups of motor vehicles are required by law.
- Most users use authorized car maintenance facilities for inspections and checkups
 - --> Users pay service fees to facilities





2. Market conditions and constraints

Turnover by maintenance types*1



^{*1} Turnover of car maintenance facilities allowed to disassemble cars by the government, including car dealers.

3. Turnover data method

Monthly Survey on Service Industries (MSSI)

- is a survey with 39,000 sample establishments whose primary industry is service industry
 - 590 sample for maintenance and repair of motor vehicles
 - --> includes establishments providing services only within their own enterprises or offering customer services with no turnover
- collects turnover
 - which includes sales from the main activity (maintenance and repair of motor vehicles) as well as from other economic activities of the establishment
 - --> turnover of incidental activities might be underestimated
 - --> turnover includes article sales



4. Results of the survey



Preliminary results

- are released 2 months after the survey month
- Final results
 - are released 5 months after the survey month

Turnover for maintenance and repair of motor vehicles





5. Future plan

Introduction of benchmark for turnover

- 2012 Economic Census for Business Activities will show turnover of entire industrial sector

Review of survey method

- To start a survey on <u>turnover by business activities</u> (top 4 service industry related activities) for <u>each major enterprise</u>
 - --> to improve the accuracy of MSSI
- To start an <u>annual survey</u> with larger sample
 - --> to supplement the Economic Census conducted every 5 years from 2012
 - --> to figure out the regional turnover and the industrial turnover in more detail



6. Summary

- Turnover for maintenance and repair of motor vehicles
 - is released as part of the results of MSSI
 - will be benchmarked to the results of Economic Census every 5 years from 2012
- Monthly Survey on Service Statistics (MSSI)
 - is an achievement of turnover statistics
 - is expected to resolve the challenges to provide more reliable turnover statistics
