
DEFINITION OF SERVICES BEING COLLECTED








VALUE ADDED CONCEPTS AND MEASUREMENT ISSUES

- For SPPI, only covers 61 (Telecommunication), 62 (Computer programming, consultancy and related activities) and 63 (Information services activities) – due to a small contribution to total of ICT
- IoS covers all activity as well as 6010 and 6020
