CPC vs. CPA and NAPCS

- CPA (section Q division 86)
 Broadly similar CPA contains some additional detail at 6th digit
 Some inconsistency with NACE
- NAPCS industry 621-2 (except 6212, 6216, and 6219)
 Quite different based on the International
 Classification of Disease (ICD) system
 Product based indices distinguish between inpatient and outpatient
